

## California Residents - Privacy policy

### Statement

The CCPA provides consumers (California Residents) with specific rights regarding their personal information. This section describes your CCPA rights and explains how to exercise those rights. CKS Prime Investments, LLC (hereinafter CKS Prime) is required to maintain a separate privacy policy for California Residents pursuant to CCPA .... With that said be advised that we only maintain and collect personal information to enhance and assist in the collection of the accounts that CKS Prime owns or services for others. We do not sell or provide personal information to others outside of the purposes of collection of a specific account.

### Access to Specific information and Data Portability rights

You have the right to request that CKS Prime Investments LLC. Disclose certain information to you about our collections and use of your personal information over the past 12 months. Once we receive and confirm your Verifiable consumer request (see Exercising Access, Data Portability, and deletion rights), We will disclose to you:

- The categories of personal information we collected about you
- The categories of sources for the personal information we collected about you
- Our business or commercial purpose for collecting or selling that personal information
- The categories of third parties with whom we share personal information
- The specific pieces of personal information for a business purpose, two separate lists disclosing:
  - Sales, identifying the personal information categories that category of recipient purchased
  - Disclosures for a business purpose, identifying the personal information categories that each category of recipient obtained.

### Non-Discrimination

CKS Prime Investments LLC will not discriminate against you for exercising any of your CCPA rights. Unless permitted by the CCPA, we will not discriminate with how your account is handled as a result of a request under the CCPA.

### Requesting Access, data portability and Deletion

To exercise the Access, data portability and Deletion rights described above, please submit a verifiable consumer request to us either by:

Only you, or a person registered with the California secretary of state that you authorize to act on your behalf, may make a verifiable consumer request related to your personal information. You may also make a verifiable consumer on behalf of your minor child. Be advised that, you may only make a verifiable consumer request for access or data portability twice within a 12-month period and Provide sufficient information that allows us to reasonably verify you are the person about whom we collected personal information or an authorized representative and/ or Describe your request with sufficient detail that allows us to properly understand, evaluate, and respond to it. We cannot respond to your request or provide you with personal information if we cannot verify your identity or authority to make the request and confirm the personal information relates to you. We will only use personal information

provided in the verifiable consumer request to verify the identity of the requestor or authority to make the request.
